



To Get a Learner Permit at a Tag Agency or Service Oklahoma Students have three options:

Option #1: (1) Complete the 10 hours of class at Brown's (2) Take the written test at an Oklahoma Vocational Center. The fee is \$28.50 and well worth the money. (3) Take the written test results, the Brown's contract, and your I.D.'s to one of the select Tag Agencies who process Learner Permits (call ahead to confirm that your local Tag Agency can issue a Learner Permit). At the Tag Agency the fee is \$42.50.

Option #2: Students may complete the 10 hours of classroom and take the items listed below to Service Oklahoma (DPS) and take the written test (20 multiple choice questions). There is no fee for the written test at Service Oklahoma. The fee for the Learner Permit is \$42.50 (credit card only). **Browns recommends option #2**

Option #3: Students may complete Brown's course (10 hours classroom and 6 hours driving) and take Brown's Completion Certificate along with the items listed below to a Tag Agency or Service Oklahoma (DPS) and the written test will be waived. We recommend students take the written test showing that the driver manual has been studied. **Browns recommends option #2**

Required Items at the Tag Agency or Service Oklahoma (DPS):

1. Must be 15 years of age or older.
2. Must show original contract from Brown's (given on the last day of class) or Brown's Completion Certificate.
3. Must have at least 1 form of ID. We recommend taking 2 or 3 forms of ID. (Birth Cert. is best; see pages 1-1 and 1-2 of the Oklahoma Driver's Manual). No copies, must be originals. Student must have Social Security card or at least know the #. See the Real ID information given in class to aid you.
4. If the student is under age 18, parent or legal guardian must accompany the applicant to sign authorization certification forms required by current law, or if no parent is present an affidavit can be presented (available on our website). If not born in the U.S., student must show valid documentation of legal resident status or proof of citizenship.

To Take the "Driving Test" with Brown's Student must meet the following requirements:

1. Must have all fees paid in full (Fees available on Brown's website or at our offices).
2. Must be 16 years of age or older.
3. Must have a valid Oklahoma Learner's Permit. Students under the age of 18 must have a Permit for 6 months, or until the age of 18. Students over the age of 18 must have a Permit for 31 days.
4. Must have a certificate of completion for a driver education course (Brown's, other driving school, public or private school, or state certified online course).
5. Anyone who is age 16 ½ or older can take the driving test even though a driver's education course has not been completed. In this case the Intermediate License (IDL) must be held for one year.
6. Driving Test can be done even if a parent, legal guardian, or notarized affidavit is not present. After passing the test the student can go to a Tag Agency the same day.
7. At the Tag Agency (if under age 18) student must be accompanied by a parent or legal guardian; otherwise, student must have a notarized affidavit signed by a parent or guardian if parents are not present (affidavit is available on the Brown's website).
8. When calling to schedule the driving test, the student must know the Learner Permit number and issue date.
9. The test fee is \$40 (\$50 for non-Browns students), **and Brown's students are never charged a retest fee (it's FREE).**
